The essential oil of Citronella Java (*Cymbopogon Winterianus*) on its own, is not impacted by the IFRA code for its use in perfuming compositions, however, the components listed above are impacted.

Essential Oils containing substantial amounts of Limonene\*\* and Linalool\*\* should only be used when the level of peroxide is kept to the lowest practical level by the addition on antioxidants in production.
