Nature Of Product: CARNAUBA WAX (100% Pure & Natural)

Copernicia Cerifera (Carnauba) Wax is a wax obtained from the leaves and leaf buds of Copernicia cerifera, Palmaceae. Very hard, high melting point natural wax.

Constituents:

Mixture of saturated vegetable Triglycerides C8– C18 and unsaturated C18. Other constituents are mono- and di-alkylglycerides, fatty acids and additional minor components that are inherently part of the vegetable oil composition.

4. FIRST AID MEASURES

- Ingestion:** Do not induce vomiting, give a glass of water. If unwell seek medical attention and show this information.
- Inhalation:** Remove casualty to fresh air, keep respiratory passages clear and seek medical attention.
