Macadamia Ternifolia Seed Oil is the fixed oil obtained from the nuts of the Bushnut, Macadamia ternifolia, Proteaceae. It consists primarily of the glycerides of the fatty acids.

#### 4. FIRST AID MEASURES

- Ingestion:** Do not induce vomiting, give a glass of water. If unwell seek medical attention and show this information.
